#### **About the Conference**

The Arab World will play a major role in international arbitration in the coming years. This conference, therefore, concerns everyone involved in, or interested in, international arbitration.

The Arab countries are experiencing a remarkable economic growth. This applies not only to the oil rich countries in the region, but also generally to the Arab World. Along with economic growth, however, there is a rapid increase in disputes. This Conference focuses on arbitration as the main dispute resolution mechanism.

The Conference will deal with critical issues in international arbitration involving parties from the Arab World. What are the options in the Arab countries and outside of them? How do courts in the Arab countries deal with arbitral agreements, arbitrability issues, and enforcement of awards? What are the arbitral procedures? How is investment arbitration dealt with? Which are the favoured venues outside the Arab countries and what factors determine the choice of the place of arbitration. These and several other questions will be addressed at the Conference.
